HOURS OF OPERATION 7am – 8pm
May 27th – September 10th – Everyday

POOL HOURS

**Adults Only Lap Swim – 7 a.m. – 9 a.m. (½ of pool width)
7 -p.m. – 8 p.m.**

Children & Teenager Swim Times – 11:30 a.m. to 1:00 p.m.

NO LIFEGUARD WILL BE ON DUTY – SWIM AT YOUR OWN RISK

Pool Rules

1. Residents can only gain access to pool area **using their own Key Fob**. Your key Fob will only be active if you have provided a signed waiver.
2. All persons using the pool do so at their own risk. HVCSA assumes no responsibility for any accident or injury in the pool or pool area.
3. HVCSA is not responsible for any loss or damage to personal property.
4. Persons using the pool area agree not to hold the community liable for any actions occurring within the pool area.
5. No person shall use the pool unless it is officially open and within hours posted. Use of the pool is at your own risk. No lifeguard will be on duty.
6. All Residents will be responsible for the actions of their guests.
A maximum of 4 guests per household are permitted * Guests must sign in and be accompanied by a resident at all times.
7. Only “noodles” are permitted in the pool and no other flotation devices will be considered. These must be taken with you when you leave the pool area.
8. **Bathers must towel dry before entering restrooms. Footwear must be worn when entering the Clubhouse, including when using the restrooms**
9. No profane language will be permitted in the pool area.
10. Proper bathing attire must be worn in the pool and must be: Designed for swimming and made of Lycra, spandex, nylon, or neoprene.
11. Water shoes are only permitted when put on in the pool area.
12. No pets are permitted in pool area.
13. Smoking or vaping is **not permitted** in the pool area.

14. Persons with a contagious skin rash, infection or open cuts or incontinence are not permitted in pool or pool area.
15. Hand sanitizers are available in the pool area for residents use.
16. No intoxicated persons will be permitted in pool area.
17. No reserving of seating or tables.
18. Glass containers, breakable objects, sharp-edged objects are not permitted in the pool area.
19. No bicycles or baby strollers will be permitted beyond the entrance of the pool.
20. Please recycle and place all trash in the containers provided. Residents are urged to assist in keeping the pool area clean. If you raise an umbrella, please lower it when you leave.
21. For any complaint about the pool or pool area, please contact the Management Office. Grievances will be reviewed by the Pool Committee.
22. The HVCSA Board of Trustees reserves the right to change any of the above rules at any time, with proper notification given to residents.

Rules for Children & Teenagers under 18

1. Swimming hours for children & teenagers are 11:30 a.m. to 1:00 p.m. every day and no one under 18 years of age is permitted in pool area other than times listed above.
2. **Children unable to demonstrate their ability to swim are not permitted in the pool or pool area. All children under the age of ten (10) must be accompanied in the water by an adult at all times.**
3. Life vests are not permitted (except for ADA cases). Inflatable arm bands are not permitted.
4. Children in diapers or swimmies of any kind are not permitted in the pool area.
5. Running, pushing, diving, jumping off the side of the pool, splashing, rough play, standing or sitting on another's shoulders, will not be permitted. Violators will be asked to leave the pool area.
